considering that feedback, on October 12, 2006, another draft of the proposed new rule was posted on the rules clearance web page of the Department (http://www.goldenbuckeye.com/rules/draft.html) for two weeks to allow for further feedback. After considering that input, the draft of the proposed new rule was further revised, then posted for a second two-week comment period on November 8, 2006. After considering that input, the draft of the proposed new rule was further revised, then filed with JCARR.
