Each rule in Chapter 173-39 primarily exists to comply with section 173.391 of the Revised Code, which requires ODA to adopt rules to establish the requirements and standards for certified providers.

This rule establishes the requirements to become, and to remain, an ODA certified provider of homemaker.

ODA proposes to amend this rule to achieve the following:

- 1. 1. Give providers the following flexibilities during a state of emergency declared by the governor or a federal public health emergency: (A) Flexibility to conduct the initial supervisor's visit by telephone, video conference, or in person. (B) Flexibility to conduct subsequent supervisor's visits by telephone, video conference, or in person, depending upon the individual's needs, but only if at least two of the supervisor's visits per year are conducted in person. (C) Flexibility to verify that they have conducted initial and subsequent visits without collecting a unique identifier of the individual or the individual's caregiver.
- 2. Add a definition of "aide."
- 3. Move the service-verification requirements from (B)(3) to (B)(7) so that it occurs in a location similar to the other service rules in the same chapter.
- 4. Combine the first 4 ways that a person may qualify to be an aide into "The person meets at least one of the qualifications to be a PCA underâ¦" since they are identical to the requirements to qualify to be a PCA.
- 5. No longer require the verification of training to include a list of instruction materials or the signatures of the trainer and tester.
- 6. Require service-verification records to include the individual's name.
- 7. Replace words that imply requirements for outdated modes of communication or in-person interaction (e.g., "document") with other words (e.g., "retain records"), or indicate that certain written requirements may also be done electronically.
- 8. Replace the 93-day deadline for conducting subsequent supervisor visits with a 90-day deadline.
- ODA also proposes to make non-substantive amendments to this rule.
