This is part of ODM's larger strategy to develop a uniform set of rules to beneÃ-Â-Ât providers who serve individuals enrolled in multiple Medicaid waiver programs.

This proposed new rule will establish the requirements for ODA-certiÃ-¬Âed providers of home modification. ODA's proposed new rule will require ODA-certiÃ-¬Âed providers of home modification to comply with (1) the requirements in 173-39-02 for every certiÃ-¬Âed provider (e.g., conducting background checks and complying with state and federal laws and regulations governing individuals' conÃ-¬Âdentiality) and (2) speciÃ-¬Âc requirements for providing home modification in ODM's current rule 5160-44-13 (e.g., service veriÃ-¬Âcation).

This proposes rule will not establish requirements for home maintenance. ODA is proposing to transfer the requirement for home maintenance to 173-39-02.5. Please review that rule for details.
