Each rule in Chapter 173-39 primarily exists to comply with section 173.391 of the Revised Code, which requires ODA to adopt rules to establish the requirements and standards for certified providers.

This rule establishes the application process for becoming an ODA-certified provider.

ODA proposes to amend this rule to achieve the following:

1. Replace words that imply a requirement for outdated modes of communication or in-person interaction (e.g., "submit") with other words (e.g., "complete").
2. Indicate that the exception to on-site (i.e., in-person) pre-certification reviews during a state of emergency declared by the governor also apply to a federal public health emergency.
3. Delete the words "ODA or, at ODA's sole discretion" in paragraph (C)(2) of this rule because the words are unnecessary.
4. Refer to form ODM10172 in paragraph (D) of this rule.
5. Replace "on June 11, 2020" in paragraph (G) of this rule with "when the provider completes an online application followed with an email to provider\_enrollment@age.ohio.gov."
