ODA proposes to amend the rule to make corrections to the rule ODA adopted on September 1, 2016.

The rule regulates AAA-provider agreements for meals with a therapeutic diet, medical food, or food for a special dietary purpose, when they are paid, in full or in part, with Older Americans Act funds.

In (A)(4), ODA proposes to replace "regime" with "regimen."

In (B)(2)(a), ODA proposes to clarify that providers shall only honor diet orders for a dysphagia nutritive regimen if the diet order indicates whether the consumer requires thickening agents in individual components of the meal such as drinks, soups, etc. This would replace current language saying, "if the diet order requires the meals to have thickening agents." The current language leaves room for a possible misconception that the only diet orders to be honored are those requiring every item in a meal to have a thickening agent.
