This rule establishes the eligibility requirements for a person to enroll in the statefunded component of the PASSPORT Program.

ODA proposes to amend this rule to achieve the following:

- 1. Eliminate three unnecessary uses of a regulatory restrictions ("shall") from this rule especially since this rule does not regulate any Ohio business. (cf., R.C. §§ 121.95 and 121.951)
- 2. Delete references to forms since ODA is proposing to no longer require using forms.
- 3. Inserting "cooperating and" before "actively assisting" in paragraph (A)(2)(c) of this rule.
- 4. Amend paragraph (D) of this rule so that the resulting paragraph establishes the following:
- * The following new sentence at the beginning of the paragraph: "ODA's designee may allow an individual to provide verbal agreement for intent to enroll on the state-funded component of the PASSPORT program at the time of assessment if the individual is unable to provide a unique identifier of the individual."
- * Using "ODA's designee may collect a unique identifier of the individual" instead of "ODA's designee may collect the individual's handwritten or electronic signature." The latter covered only two types of unique identifiers that an individual may use to represent themselves. [See the definition of "unique identifier" in rule 173-40-01 of the Administrative Code.]
- * Replacing the deadline to collect the unique identifier from the next reassessment of the individual to thirty days after the individual's original enrollment date.

ODA also proposes to make non-substantive improvements to this rule.
