ODA is proposing to adopt this new rule as part of a larger rule package.

ODA is proposing to amend chapter 173-43 of the Administrative Code which regulates the Long-Term Care Consultation Program. In doing so, ODA is proposing to rescind the current chapter and replace it with five new rules that implement the changes that H.B. No. 1 (128th G.A.) required for the rules of the program. The proposed new rules also include references to statutes that H.B. No. 153 (129th G.A.) updated.

This proposed new rule sets forth to whom long-term care consultations are provided and the conditions under which exceptions may be made.

On January 3, 2012, ODA revise-filed the rule to:

1. Revise paragraphs (A), (B), (C), and (D) so they follow a symmetrical sentence construction. This leaves paragraph (A) of the rule as, "The nursing facility or the program administrator shall determine that the program administrator is not required to provide a long-term care consultation to an individual if any of the following apply," paragraph (B) of the rule as, "The program administrator may determine that it is not required to provide a long-term care consultation to each individual in the following categories unless the individual (or the individual's

representative) requests a long-term care consultation," paragraph (C) of the rule as, "The program administrator shall provide a long-term care consultation to each individual in the following categories so long as paragraph (A) of the rule doesn't exempt the individual," and paragraph (D) of the rule as, "The program administrator may provide a long-term care consultation to any* individual residing in a nursing facility regardless of the source of payment used to pay for the individual's care in the nursing facility." [* See below regarding "any."]

2. Replace "each" in paragraph (D) of the rule with "any."
3. Replace "so long as the individual is not exempted by paragraph (A) of this rule" in paragraphs (C) and (C)(2) of the rule with "unless paragraphs (A) or (B) of this rule exempt the individual."
4. Move the last two sentences of paragraph (C)(2) of the rule to proposed new rule 173-43-02 of the Administrative Code because the sentences require a process. The sentences said, "In this case, the nursing facility shall inform the program administrator of such an individual no later than seventy-two hours after the expiration of the time limit. Upon being notified, the program administrator shall determine whether or not a long-term care consultation is required."
5. Upload a revised public-hearing notice.
6. Revise this RSFA.

On January 13, 2012, ODA refile the rule to:

1. Reorder the paragraphs so the paragraph on required consultations appears before the paragraphs on exemptions from required consultations. (cf., left-branching vs., right-branching in "Advanced Legal Drafting." (Bryan Garner. Dallas, TX: Lawprose, Inc. (c) 2007. Pp., 59-67.)). This makes paragraph (C) of the rule into paragraph (A) of the rule and reorders other paragraphs in the rule and references in the rule to the paragraphs.
2. Insert a comma after "categories" in paragraph (A) of the rule [formerly paragraph (C) of the rule].
3. Insert a comma after "applies" and another comma after "apply" in paragraph (A)(1) of the rule [formerly paragraph (C)(1) of the rule].
4. Delete "rule" as it appeared before "5123:2-14-01" in paragraph (A)(2) of the rule [formerly paragraph (C)(2) of the rule].
5. Replace the colon at the end of paragraph (C)(3) of the rule [formerly paragraph (B)(3) of the rule] with "; or,".
6. Delete "has already" in paragraph (C)(4) of the rule [formerly paragraph (B)(4) of the rule].

7. Replace "during" in paragraph (C)(4) of the rule [formerly paragraph (B)(4) of the rule] with "within."

8. Revise this RSFA.

Although section 173.42 of the Revised Code requires ODA to develop and administer the Long-Term Care Consultation program, H.B. No. 153 (129th G.A.) moved the program's funding to budget line item GRF-600-525, which is under JFS, not ODA. Therefore, ODA estimates that the proposed adoption of this new rule will have no impact upon the biennial budget that the Ohio General Assembly established for ODA in H.B. No. 153.

Nevertheless, ODA estimates that the proposed adoption of this new rule will also have no impact upon the biennial budget that the Ohio General Assembly established for line item GRF-600-525. In FY11, area agencies on aging provided 53,035 long-term care consultations. So far in FY12, area agencies on aging are providing fewer long-term care consultations than at the same point in FY11.

Although it is possible that public awareness of the free long-term care consultations, the aging of Ohio's population, and other changes to the long-term service and support system could lead to an increasing number of long-term care consultations, ODA does not estimate that the adoption of this new rule will create an increase in the number of long-term care consultations for FY12 or subsequent years. Therefore, ODA estimates that the proposed adoption of this new rule will

have no impact upon the biennial budget that the Ohio General Assembly established for GRF-600-525.
