Chapter 173-45 of the Administrative Code regulates the Long-Term Care Consumer Guide (Guide).

ODA proposes to amend this rule as part of its review of Chapter 173-45 of the Administrative Code, which satisfies the requirements for ODA to review the

chapter no less often than every 5 years.

The rule requires the Guide to display comparative information about facilities following a search query.

ODA proposes to amend the rule to only require publishing comparative information on quality measures if the Guide publishes quality measures.

ODA also proposes to make non-substantive amendments that mostly pertain to punctuation and grammar.

On October 20, 2015, ODA made refiled the rule to do the following:

1. Replace "criteria" in paragraph (A) of the rule with "requirements."
2. No longer replace paragraph (B)(2) of the rule with paragraph (C). Instead, paragraph (B)(2) would say that the Guide will publish the quality measures described in rule 173-45-07 or an electronic link to the CMS website where the Guide#s viewers may access the quality measures.
3. Schedule a 2nd public hearing.
4. Update this RSFA.
