ODA proposed to add conditional language to rule 173-45-07 of the Administrative Code so that ODA is only bound to display the CMS-calculated quality measures in the Guide, IF the Guide displays quality measures. To date, the Guide does not display such measures.

ODA also proposes to make a non-substantive amendment to the rule.
