Provider participation.**RULE SUMMARY**

6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

ODA has reviewed rule 173-6-05 of the Administrative Code in accordance with Sub. H. B. No. 473 (121st G. A.) and section 119.032 of the Revised Code, which require a state agency to review each rule every five years to determine whether to continue without change, to amend, or to rescind a rule. Because ODA decided to amend the language to a significant degree, the amended language would account for more than fifty percent of the total language if ODA filed this rule as a proposed amended rule. Therefore, in accordance with the "fifty per cent guideline" in the Fourth Edition of the LSC Rule Drafting Manual (May, 2006), ODA is now filing this proposed new rule to replace rule 173-6-05 of the Administrative Code.

This rule was posted on the ODA web site for a public comment period on April 11, 2007 and received no opposition to the filing of this rule.

This proposed new rule would:

[1] Outline the procedures a provider must take if that provider wishes to become a participating provider in the Golden Buckeye program. Compared to the language in rule 173-6-05 of the Administrative Code that this proposed new rules replaces, this proposed new rule allows the provider to apply online;

[2] State the terms to which a provider must agree when the provider agrees to participate in the Golden Buckeye program;

[3] Outline the enrollment procedures to be taken by ODA or an administrator designated by ODA once it receives an application from a provider;

[4] Declare that a participating provider may discontinue participating in the program at any time for any reason;

[5] Declare that a participating provider may contact ODA or an administrator designated by ODA to revise any information submitted to ODA in the application process (e.g., type of discount offered); and,

[6] Declare that ODA may cancel the participation of a provider in the Golden Buckeye program at any time and for any reason.

COST OF COMPLIANCE TO A PROVIDER: Any entity wishing to be participating provider in the Golden Buckeye program may do so voluntarily. For the provider that becomes a participating provider in the Golden Buckeye program, the cost of compliance will be whatever benefit or discount a business agrees that it will provide cardholders when it applies to become a participating provider. Additionally, it may take a few minutes of administrative time for an employee of the provider to complete the application and additional time if the provider has multiple sites that are also part of the application.

BENEFIT FOR A PROVIDER: Offering exclusive benefits and discounts to the approximately 2,000,000 Ohioans that have a Golden Buckeye Card may increase the sales to those cardholders who may choose to do business with that provider over one who does not offer a discount to cardholders.
