This rule is being proposed for amendment as part of a larger effort by the Department to distinguish in Chapter 173-6 of the Administrative Code between "rebates" and "discounts" in order to provide clarity to drug manufacturers who seek to integrate their means-tested discount programs with the Golden Buckeye Prescription Drug program.

7. If the rule is an AMENDMENT, then summarize the changes and the content of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

Rule Content: This rule reflects the Department's statutory authority to contract with one or more entities to administer prescription drug programs for Golden Buckeye Program cardholders; describes how contracts will be awarded by the Department and the necessary content of all proposals submitted by interested entities; authorizes the Department to force any administrator to modify its conduct of a program for certain stated reasons; establishes a maximum term for all contracts; authorizes the termination of contracts by the Department under certain circumstances; and makes all contracts subject to approval from the Controlling Board.

Rule Changes: The rule is being amended to clarify the Department's intent in light of the definitions added to existing/proposed rule 173-6-02 of the Administrative Code; to require any entity wishing to serve as an administrator to submit a proposal reflecting that the entity will use one hundred percent of any drug discounts it receives to reduce the prescription purchase costs of cardholders; to delete or replace the word "discount" wherever it is used inconsistent with the definition of "drug discount" in proposed new rule 173-6-02 of the Administrative Code.
