6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

H.B.59 (130th G.A.) enacted section 173.60 of the Revised Code to create the Nursing Home Quality Initiative (NHQI). As a result, ODA proposes to adopt this rule and the rest of Chapter 173-60 of the Administrative Code to implement regulations on quality-improvement projects for the NHQI.

Proposed new rule 173-60-03 of the Administrative Code would establish the approval and rescission processes for quality-improvement projects.

ODA estimates that the adoption of this proposed new rule would have no impact upon the biennial budget that the Ohio General Assembly established for ODA in H.B.59 (130th G.A.). H.B.59 not only established ODA's biennial budget, it also authorized the NHQI. Therefore, the General Assembly factored NHQI expenses into ODA's budget. No requirements in the proposed new rule would cause ODA to exceed that budget.

ODA estimates that the adoption of this proposed new rule would create a cost of compliance for sponsoring entities that would ask ODA to approve their quality-improvement projects. The entities would need to spend administrative time to email details about their projects to ODA.

A.) Does this rule require a license, permit, or any other prior authorization to engage in or operate a line of business? **Yes**

SPONSORS' QI PROJECTS: Although a sponsoring entity's quality-improvement project may already be in operation in nursing homes, the project may not be part of the NHQI unless ODA approves the project. This proposed new rule establishes the process for approval and rescission of those projects.

NURSING HOMES: This proposed new rule does not require a license, permit, or any other prior authorization for a nursing home to operate a line of business.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **No**

SPONSORS' QI PROJECTS: The proposed new rule wouldn't impose penalties for non-compliance on sponsoring entities of quality improvement projects. ODA would not sanction a sponsoring entity whose project doesn't quality. ODA would simply not add the project to the list of approved projects.

NURSING HOMES: Although the NHQI addresses nursing homes, this proposed new rule wouldn't impose penalties for non-compliance to nursing homes, because it only addresses the approval and rescission processes for deciding which quality-improvement projects ODA will approve and list on the Ohio Long-Term Quality Initiative website (<http://aging.ohio.gov/ltcquality/>).

The Ohio Department of Health, as the state survey agency, has the authority to take action against a nursing home that doesn't comply with section 3721.072 of the Revised Code.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

SPONSORS' QI PROJECTS: An entity that sponsors a quality-improvement project may propose that ODA approve its project by sending a description of the project to the email inbox that ODA provides on the Ohio Long-Term Care Quality Initiative website (<http://aging.ohio.gov/ltcquality/>). There would be no fee to seek

ODA's approval. The only expenditure would be the administrative time it would take to email information to ODA.

NURSING HOMES: The proposed new rule would not require nursing homes to make specific expenditures or to report information.
