This rule require responsible parties to conduct database reviews on applicants and employees in direct-care positions and requires doing so before requesting criminal records on those applicants and employees.

The Ohio Department of Rehabilitation and Corrections recently changed the URL for its offender-search database. Therefore, in this rule ODA proposes to replace "http://www.drc.ohio.gov/OffenderSearch/Search.aspx" with "https://appgateway.drc.ohio.gov/OffenderSearch."

The HHS Office of Inspector General changed the URL for its exclusionary database. Therefore, in this rule, ODA proposes to replace "http://exclusions.oig.hs.gov" with "https://exclusions.oig.hhs.gov/."
