The definitions included in this rule clarify program eligibility, the role of school districts of residence, how services to students are determined and modified, and what organizations can participate in the program as service providers. Changes to the rule include (I)Align the definitions for both Autism and Peterson programs to streamline administration. (M)(1) Delete language that is expressly stated in ORC 3310.41(A)(6)(1). (M)(2) Aligns with Peterson Scholarship program rule. (O) Differentiate between a school providing all services to students versus a school or provider providing only the education program or related services. Differentiation between providers reduces the administrative burden on schools providing comprehensive services.
