In 2005, the maximum scholarship amount was increased from \$15,000.00 to \$20,000.00 per pupil, and the rule is being updated to reflect this change in law. Once a scholarship is awarded to a child, funds are deducted from the district's foundation payment. Please note that the Department has issued scholarships in compliance with this change in law once it became effective. Any deduction from a district's foundation payment is offset by the amount awarded under a scholarship.
