This rule allows the Department to differentiate between the process for initial and reissue of school charters. Expands the time frame during which an application can be submitted from two weeks to two months. Allows more flexibility for schools seek reissuance of a charter due to one or more changes that occur throughout the

school year. Clarifies that schools seeking an initial charter will submit the information necessary to allow the Department to determine if there is compliance with the Operating Standards. Allows for monitoring of schools that receive an initial charter. Site visits provide the opportunity for the Department to provide any necessary technical guidance.
