Pursuant to 3301-39-04, a nonpublic school that fails to comply with 3301-35-09 or any other applicable Ohio laws and rules and fails to address the non-compliance issues, may be subject to having its charter revoked. The revocation of the charter shall be subject to a hearing pursuant to Ohio Revised Code Chapter 119.
