ODH is proposing to amend this rule to ensure consistency with recent revisions to the Ohio Revised Code, and to change several definitions used throughout the Ohio Administrative Code Chapter 3701-12.

This rule provides definitions of numerous terms used throughout the Ohio Administrative Code Chapter 3701-12, such as "affected person," "certificate of need," and "existing healthcare facility." ODH proposes to amend the definition of "existing healthcare facility" to include statutory language changes pertaining to county operated facilities, which will become effective on June 13, 2008. ODH further proposes to correct several cross-citations.
