The rule provides definitions of numerous terms used throughout Ohio Administrative Code Chapter 3701-12, such as "affected person," "certificate of need," and "existing healthcare facility." With the approval of the Public Health Council, proposed amendments will change the definition of "existing healthcare facility," and add numerous new definitions for use in the CON program, such as "reviewable ruling," "principal participant," and "political subdivision." Furthermore, several definitions, such as "gamma knife unit," "obstetric care service," and "perinatal bed," are proposed for deletion from the rule as a result of no longer being subject to the CON requirements.
