The Ohio Department of Health is seeking amendment of this rule to provide clarification regarding reviewable activities under CON law, and to make minor grammatical revisions.

This rule lists various activities that are reviewable activities, and thus cannot be conducted without a valid certificate of need ("CON"). Such activities include, but are not limited to, the establishment, development, or construction of a new long-term care facility; the replacement of an existing long-term care facility; and an increase in long-term care bed capacity. The rule also lists activities that are not reviewable activities, such as the acquisition of computer hardware or telephone systems and the construction of parking facilities. ODH is proposing to amend the rule to delete the "reategorization of registered hospital beds to skilled nursing beds or long-term care beds" from the list of reviewable activities. The rule is further amended to change the "Joint Commission on Accreditation of Healthcare Organizations" to the organization's current name, the "Joint Commission." Finally, minor grammatical changes were made to the rule.
