All rules in Chapter 3701-12 are part of the Certificate of Need Application (CON) process. Any person seeking to engage in reviewable activities involving long-term care facilities or long-term care beds must obtain this written approval granted by the Director of Health.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **No**

This rule does not establish penalties; however, persons who engage in reviewable activities without obtaining a CON may be subject to a civil monetary penalty of \$3,000 up to \$250,000 imposed by the Director. The Director may also revoke or refuse to issue a license, or reduce the bed capacity of a facility for violations of CON requirements.
