The Ohio Department of Health is seeking amendment of this rule to clarify CON application and review requirements.

This rule describes the Certificate of Need ("CON") application and review process, and further sets forth the public notice requirements for CON applicants.

The proposed amendments do the following: 1) extend from three to seven days the time frame that newspaper notice of a proposed CON project must be provided; 2) require an applicant to provide written explanation of a failure to timely comply with the newspaper notice requirement; and 3) clarify that the Director of Health shall deny an application if the applicant fails to provide timely newspaper notice, or fails to document in writing that timely notice was not provided for reasons beyond the applicant's control.
