With the approval of the Public Health Council, the Ohio Department of health is seeking rescission of current rule 3701-12-08 and replacement with new rule 3701-12-08 as a result of recent changes to the Certificate of Need (CON) statutes.

This rule describes the Certificate of Need (??CON??) application and comparative

review process and further sets forth the public notice requirements for CON applicants. The rule establishes comparative review periods for applications for the period of July 1, 2010 through June 30, 2012 and for each four year period following. Furthermore, the rule specifies when an application for a CON shall be subject to a comparative review, including, but not limited to, when the proposed increase in beds is attributable solely to relocation of existing beds from an existing health care facility in a county with excess beds to a health care facility in a county in which there are fewer long-term care beds than the county's bed need; conversion of infirmary beds to long-term care beds; or an increase of hospital beds registered pursuant to section 3701.07 of the Revised Code as long-term care beds.
