ODH has chosen to conduct a five-year review of Chapter 3701-12 in conjunction with making necessary statutory amendments. ODH is requesting rescission of rule 3701-12-09 and replacement with a new rule 3701-12-09 to clarify the CON application process and to comply with LSC rule drafting requirements.
