The passage of HB 487 required revisions to Chapter 12 of the Ohio Administrative Code to clarify the Certificate of Need (CON) program and application process. ODH has chosen to conduct a five-year review of Chapter 3701-12 in conjunction with making necessary statutory amendments. ODH is filing new rule 3701-12-12 to clarify the statutory requirements of 3702.522.

New rule 3701-12-12 establishes the conditions under which a revised application for a CON may be filed as authorized by ORC section 3702.522 and incorporates components of previous rule 3701-12-10(K) that pertained to revised applications. ORC section 3702.522 only authorizes a revision to a CON application for the proposed site location and this request must be made prior to the mailing of a notice of completeness and include a non-refundable fee of twenty-five percent of the original fee. The enactment of ORC section 3702.522 allows for a CON applicant the opportunity to seek an alternate site for the development of a proposed project under certain conditions. The new rule clarifies those conditions and provides guidance for an applicant to adhere to filing requirements.

All rules in Chapter 3701-12 are part of the Certificate of Need Application (CON) process. Any person seeking to engage in reviewable activities involving long-term care facilities or long-term care beds must obtain this written approval granted by the Director of Health.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

Persons who engage in reviewable activities without obtaining a CON. The Director may impose civil monetary penalties of \$3000 up to \$250,000 depending on the type of violation; revoke or refuse to issue a license; or reduce the bed capacity of a facility for violations of CON requirements.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

The rule requires the submission of an application and a non-refundable fee of twenty-five percent of the original fee paid.
