The Ohio Department of Health is seeking amendment of rule 3701-12-18 to ensure language is consistent with statutory language.

This rule sets forth the requirements that a certificate of need ("CON") holder must follow in order to maintain the validity of the CON. The rule further describes the procedures that the Director of Health follows in order to monitor the project implementation activities of CON holders. Proposed amendments 1) remove language accepting a contract for construction as evidence of the obligation of capital expenditures as required to maintain a valid CON; 2) state that the twenty-four month period in which capital expenditures must be obligated shall not be extended by any means; and 3) clarify that if the requirements are not met within the specified time frame the CON will expire whether or not the Director sends a notice and no further action is required by the Department.
