The five year review of Chapter 3701-12 is due September 1, 2018. Due to the number of rules impacted by the statutory changes required in HB 483, ODH decided to conduct an early five-year review of Chapter 3701-12 in conjunction with making all necessary statutory amendments.

O.A.C. rule 3701-12-23.2 sets forth the additional criteria the Director must consider for an application for a certificate of need to replace an existing long-term care facility or to relocate existing long-term care beds from one site to another. The rule is amended to remove outdated terminology.
