This rule sets forth the criteria for the Director of Health's review of certificate of need applications for existing or proposed long-term care facilities. ODH is proposing to amend the rule to achieve consistency with recent statutory revisions allowing the Director to approve CON application to a project that proposes to correct all life safety code, state fire code or state building code violations at an existing health care facility to which beds are being relocated. ODH is also proposing to update citations to section 3702.59 of the Ohio Revised Code.
