Page 2 Rule Number: 3701-17-05

This rule summarizes certain actions from which applicants, nursing homes, staff, and other individuals are prohibited.

The rule has been amended to clarify who is a transient guest for purposes of the rule and to provide exceptions to the definition of "transient guest," including individuals in the facility for short term respite stays, individuals helping a resident adjust to life in the home, and individuals staying with a resident at end-of-life.
