ODH is proposing Chapter 3701-17 as part of the five-year rule review required by section 119.04 of the Revised Code.

This new rule sets forth the responsibilities of the nursing home administrator and the operator, and, also, the requirements for quality assurance and performance improvement (QAPI).

The rule is being rescinded and replaced in accordance with Legislative Service Commission rule drafting requirements. Changes to the rule include amendments for Page 2 Rule Number: 3701-17-06

clarity and requirements for a QAPI program consisting of at least a quality assurance committee and participation in a quality improvement program every two years. The rule also requires the quality assurance committee with tracking and monitoring the homes' infection control program, and to clarify that the QA records are not subject to disclosure but that the home must document the ongoing existence of an effective QA committee.
