This rule details the required training and competency evaluation for state tested nurse aides working in long term care facilities.

The rule has been amended to require training in and evaluation of principles of person-centered care. Additionally, a home that "holds itself out" as providing specialty care must provide additional annual training in that care to nurse aides.
