This rule details the required training and competency evaluation for state tested

nurse aides working in long term care facilities. Definitions for "competency evaluation program" and "training and competency evaluation program" are proposed. Also, language used in these definitions is stricken throughout the rule to aid in ease of reading. Finally, person-centered care language is added to replace previous language.
