With the approval of the Public Health Council, ODH is proposing to amend this rule as part of the five year review process.

This rule sets forth the required training for dining assistants, and also sets the requirements for how dining assistants may be used in the nursing home. Attached to the rule is an appendix that contains the dining assistant program curriculum.

The current appendix is proposed for rescission, with a new appendix proposed in its place. Changes include: 1) adding a definition for "training and competency evaluation program;" 2) reducing the dining assistant curriculum requirement from ten hours to nine; and 3) updating the appendix to reflect that required-hour change and to include person-centered language.
