The current appendix is proposed for rescission, with a new appendix proposed in its place. Changes include: 1) adding a definition for "training and competency evaluation program;" 2) reducing the dining assistant curriculum requirement from ten hours to nine; and 3) updating the appendix to reflect that required-hour change and to include person-centered language.
