Due to recent changes in federal tuberculosis testing guidance, the Public Health Council proposes to amend rule 3701-17-07.

This rule sets forth the general qualifications for individuals employed by a nursing homes, including, but not limited to minimum experience and education levels. The

Public Health Council proposes to amend the rule to allow for the use of the blood assay for M. tuberculosis test (BAMT) test in addition to the Mantoux test for required annual testing of staff members.
