ODH is proposing Chapter 3701-17 as part of the five-year rule review required by section 119.04 of the Revised Code.

This rule sets forth the qualifications for personnel working in nursing homes, to

include licensed nursing home administrators, activities professionals, and food service managers.

The rule has been amended to track Food Code requirements; to require training in person-centered care, and to prohibit employment of individuals who have a finding of abuse, neglect, or misappropriation on the nurse aide registry of Ohio or another state, or who has had a disciplinary action taken against them by a licensing board because of a finding of abuse, neglect, or misappropriation.
