This rule establishes the minimum personnel requirements for nursing homes, including nursing, dietary, activities, and ancillary staff. ODH has amended the rule to require a nursing home to have social services staff to provide for the medically-related social service needs of residents and to remove the provision requiring a nursing home with fewer than 120 beds to have a social worker either part-time or as a consultant.

The proposed amendment will reduce the cost of compliance. Homes with fewer than 120 beds will be able to replace a part-time consultant social worker with social services staff, with the ensuing savings: social worker (\$22.85 per hour or \$47,530 per year); social service staff (\$13.84 per hour or \$28,790 per year). These fugures are based upon United States Department of Labor, Bureau of Labor Statistics, Occupational Employment and Wages for the State of Ohio, May 2011, using the codes for Healthcare Social Worker (21-1022), Social and Human Service Assistants (21-1093).
