This rule establishes the minimum personnel requirements for nursing homes,

including nursing, dietary, activities, and ancillary staff.

The rule has been amended to require homes to assess the staffing needs of the home, and to clarify sharing of staff between ODH licensed facilities. Two paragraphs have been re-ordered for ease of reading.
