With the approval of the Public Health Council, ODH is proposing to amend this rule as part of the five year review process.

This rule details the requirements for resident medical assessments and annual tuberculosis testing. Proposed amendments 1) eliminate outdated language that

refers to an annual report compiled by ODH; 2) delete requirements for pneumonia and influenza vaccinations because those requirements are moved to rule 3701-17-13; and 3) correct a citation.
