ODH is proposing to amend this rule as a result of discussions with the regulated industry.

This rule requires nursing homes to have and follow infection control procedures that limit the likelihood of transmission of disease. The rule is amended to require each nursing home to develop a tuberculosis control plan in accordance with the most recent guidance issued by the United States Centers for Disease Control and Prevention and to retain documentation of compliance.
