With the approval of the Public Health Council, ODH is proposing to amend this rule as part of the five year review process.

This rule requires each nursing home to have a medical director and establishes the medical directors' duties, including periodic evaluation of residents. The rule also

requires each home to ensure that every resident is under the supervision of a physician. Proposed amendments reorganize the rule for ease of reading and to reflect current standards. Specifically, both "medication" and "treatment" have been given their own paragraphs that reflect current professional standards. Additionally, the rule now recognizes "other licensed health professional[s] acting within the applicable scope of practice." Finally, the pneumonia and influenza vaccination requirements are inserted (they are moved from rule 3701-17-10).
