This rule requires nursing homes to develop plans of care for residents; to ensure the plan of care is followed and updated; and provide for transfer and/or discharge plannings. ODH proposes to amend the rule to recognize "other licensed health professional[s] acting within the applicable scope of practice" and to add examples to staff disciplines needed to meet resident needs. Additionally, proposed amendments require a home to provide adequate supervision to residents who have been assessed for risk of falls, elopement, or both. Finally, the rule is being reorganized for ease of reading.
