With the approval of the Public Health Council, ODH is proposing to rescind current rule 3701-17-15 and to replace it with a new version. These proposals are a result of the five year review process.

This rule outlines how restraint may be used in nursing homes, including the need for a physician's order and periodic review. This new rule reorganizes the previous rule for ease of reading. Further, the rule now defines "prone restraint" and "transitional hold" and prohibits their use. Language is also modified to become more person-centric.
