With the approval of the Public Health Council, ODH is proposing to amend this rule as part of the five year review process.

This rule outlines what records are to be kept by a nursing home and for how long. ODH is amending this rule to require the home to note the resident's Medicare Part D plan, if any, in the resident's admission record; to recognize "other licensed health professional acting within the applicable scope of practice;" and to require a photgraph of resdents identified as an elopement risk. Further, ODH proposes to require homes to notify ODH where records will be stored after closure of the home.
