With the approval of the Public Health Council, ODH is proposing to amend this rule as part of the five year review process.

This rule sets requirements for smoking and fire safety requirements for ashtrays

and wate containers. ODH proposes to amend this rule to track language from divisiion (D) of section 3794.03 of the Revised Code, commonly known as the "smoking ban." Further proposed amendments require a home that permits outdoor smoking to make accommodations for residents during adverse weather conditions.
