Current rule 3701-17-21 only mentions shared space in relation to adult day care programs; the proposed amendments clarify that a nursing home that shares space with a licensed residential care facility must meet the dining and/or recreation space requirements for residents of that facility.

Building Shared Dining/Recreation Space:

A review of nursing home construction projects that have undergone Certificate of Need review place the cost of building a nursing home at \$115 per square foot.

A nursing home that chooses to share space with, for example, a 50-bed residential care facility, would incur the following costs (throug, as noted above, this is not a new cost): Dining space at \$115: 25 sq. ft  $(50 \times 115) = 143.750$ .; Recreation Space at \$115: 25 sq. ft  $(50 \times 75) = 107.813$ .
