This rule sets forth plumbing, building and sanitation requirements for nursing homes. The rule has been amended to, beginning July 1, 2015, prohibit the use of overhead paging in a nursing home except in the case of urgent public safety or urgent clinical operations. The amendment further requires each nursing home to develop and make available a written policy on its use of overhead paging.
