With the approval of the Public Health Council, ODH is proposing to amend this rule as part of the five year review process.

This rule establishes space and occupancy requirements for resident sleeping rooms. ODH proposes to amend this rule to clarify the timeframes for compliance with square footage and room capacity requirements: Buildings occupied as nursing homes (1) prior to December 25, 1964; (2) between December 22, 1964 and July 17, 2002; and (3) after July 17, 2002.
