This rule sets forth the disaster preparedness requirements that nursing homes must follow in the event of fire or other emergency. This rule also requires emergency evacuation drills. ODH proposes to amend the rule to require a plan for protection of all persons in the event of fire, to include a fire watch, to require notice to local law enforcement when a resident is missing, and for staff fire training to be conducted by the state fire marshal or township, municipal, or local legally constituted fire department. Finally, the proposed rule clarifies when fire drills must be conducted and under what conditions.
