The rule sets forth the responsibilities of a residential care facility with regards to changes in a resident's health status and other incidents, as well as infection control.

This rule has been amended to clarify what an incident report must contain and to conform to Legislative Services Commission rule-drafting requirements.

11/8/2012: Paragraph (B)(2) is being changed to remove language intended to clarify the contents of an incident log. Stakeholders expressed concern that the initial proposed language created an incident report, rather than a log.
